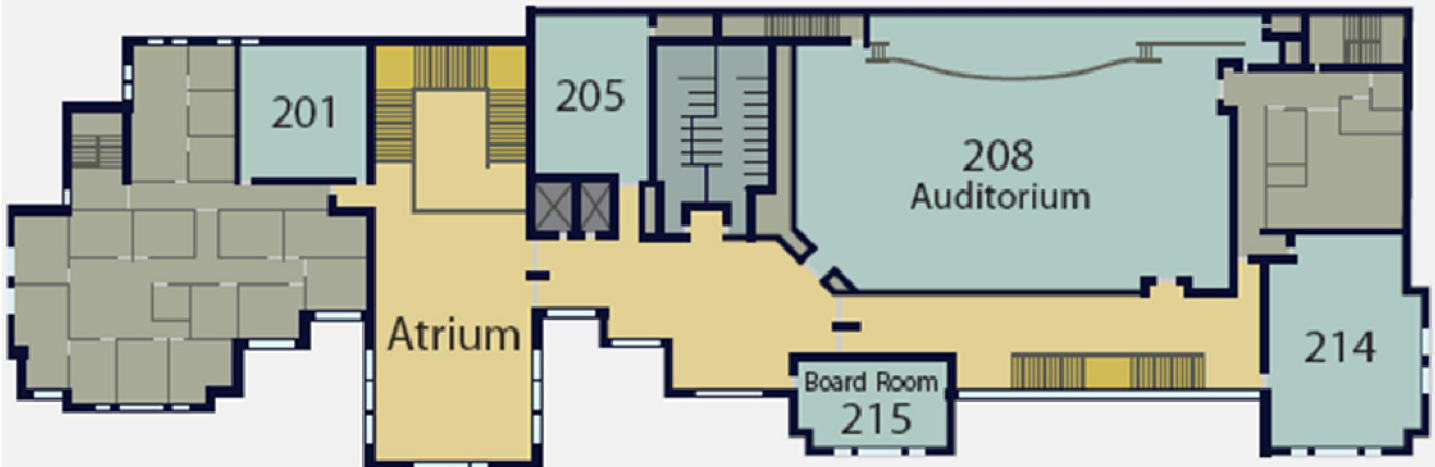




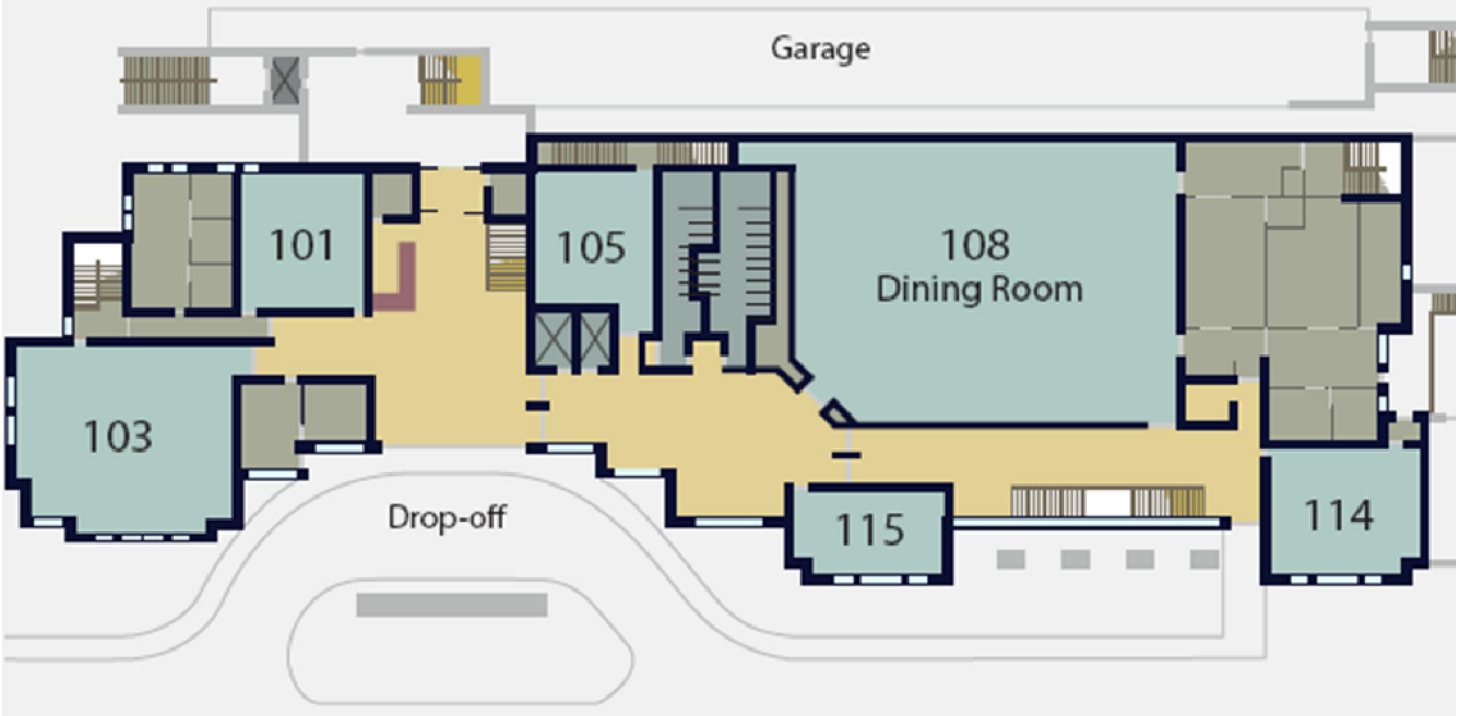


# FSU Turnbull Conference Center Floor Plan

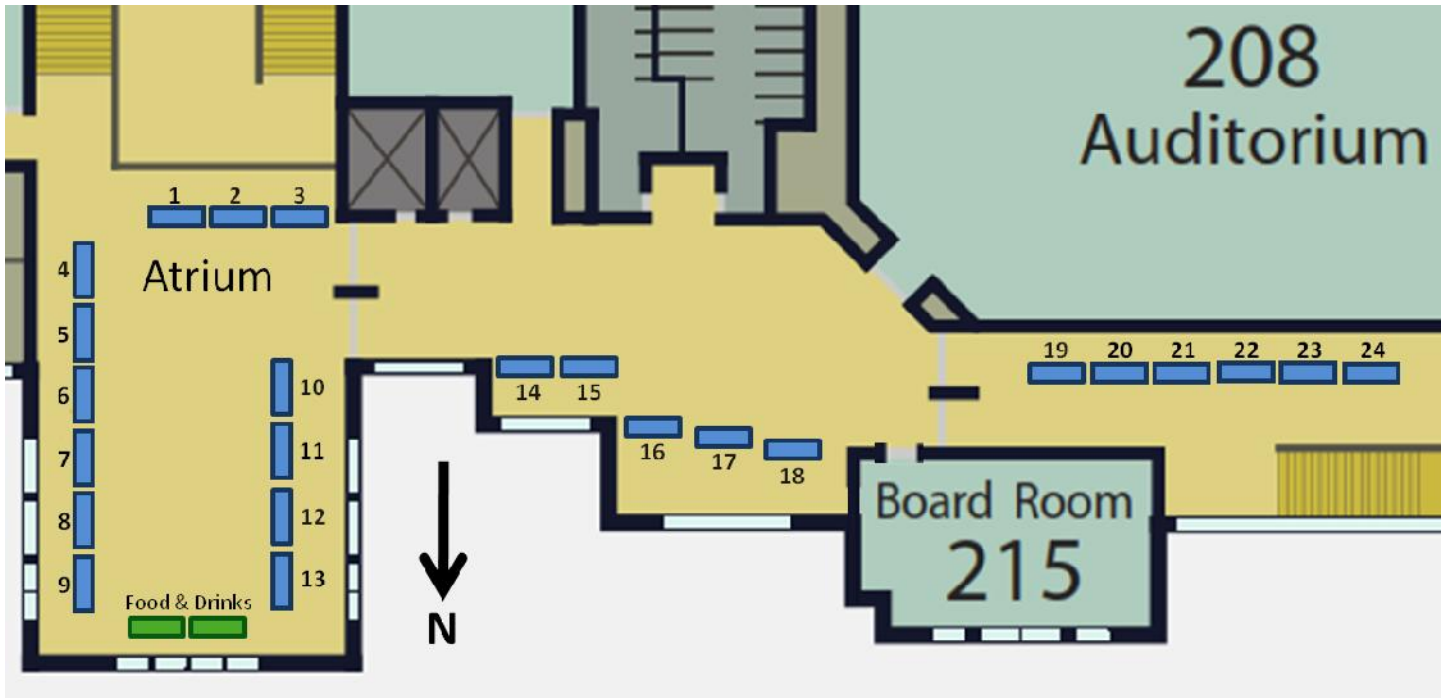
